Brief History since the Last Comprehensive Evaluation:

October 2024 Council Meeting

Based on review of the comprehensive report of the evaluation team, the school's written response to the team report, and the dean's presentation to the Accreditation Committee on October 16, the Council granted **accreditation with monitoring** of the Barry University School of Podiatric Medicine through October 2029. On-site re-evaluation may be expected during the spring of 2029. The maximum first-year class enrollment is 67.

Following review of the on-site team report, the Accreditation Committee and the Council determined that the college is in noncompliance with areas from CPME 120, *Standards and Requirements for Accrediting Colleges of Podiatric Medicine* regarding effective communication, sufficient faculty, strategic planning, and ongoing evaluation processes (Standard 1B Strategic Planning; Standard 1D

Ongoing Evaluation Process; Standards 2B Relationship with Parent Institution, 3B Chief Academic Officer, and 6F Organization; and Standard 5B Faculty Size). The school is required to submit a progress report for consideration at the May 2025 meetings of the Accreditation Committee and the Council that includes the school's progress in correcting the areas of noncompliance.

May 2025 Council Meeting

Following review of the progress report, the Accreditation Committee and the Council determined that the college remains in noncompliance with Standard 1B Strategic Planning; Standard 1D Ongoing Evaluation Process; and Standard 5B Faculty Size from CPME 120, *Standards and Requirements for Accrediting Colleges of Podiatric Medicine*. The college is required to submit a progress report for consideration at the October 2025 meetings of the Accreditation Committee and the Council that includes the college's progress in correcting the areas of noncompliance.

The school must take appropriate action to bring itself into compliance with the requirements. The areas of noncompliance cited in October 2024 following the June 2024 on-site visit (Standard 1B Strategic Planning; Standard 1D Ongoing Evaluation Process; and Standard 5B Faculty Size) must be corrected by October 2026 unless an extension for good cause is requested and granted.

October 2025 Council Meeting

Following review of the progress report, the Council accepted the Accreditation Committee's recommendation and voted to change the accreditation status to **accreditation**, from accreditation with monitoring status, as the areas of noncompliance have been corrected.

Because the school is in compliance with all accreditation standards and requirements and demonstrated this full compliance within one year of the comprehensive evaluation decision in October 2024, **the Council voted to extend accreditation for a maximum period of eight years from the previous accreditation review**. The next comprehensive site visit will take place in spring 2032 with an accreditation decision made at the October 2032 meeting.
