CPME Mission and Goals

The Council on Podiatric Medical Education (Council or CPME) is an autonomous, professional accrediting agency that evaluates and accredits educational institutions and programs in the specialized field of podiatric medicine. CPME is designated by the American Podiatric Medical Association to serve as the accrediting agency for podiatric medical education.

CPME Mission

The mission of the Council is to promote the quality of graduate education, postgraduate education, certification, and continuing education. By confirming these programs meet established standards and requirements, the Council serves to protect the public, podiatric medical students, and doctors of podiatric medicine.

To achieve its mission, CPME has adopted and prioritized the following objectives:

1. Assure and enhance the quality of the educational outcome at all levels in podiatric medicine.
2. Assure and enhance the quality of the educational process at all levels in podiatric medicine.
3. Maintain compliance with the criteria for recognition established by the U.S. Secretary of Education and the Council for Higher Education Accreditation.
4. Regulate compliance with standards, requirements, and criteria established by CPME.
5. Establish and maintain good lines of communication with the community of interest.
6. Be responsive to innovative concepts in podiatric medical education and training.
7. Review and resolve complaints received about colleges, providers of continuing education, residency and fellowship program sponsors, and specialty boards.
8. Seek out ways to improve upon the quality and methods of the CPME evaluation processes.
9. Participate in the national discussion on issues concerning accreditation, including, but not limited to, maintaining membership in the Association of Specialized and Professional Accreditors.

Guiding Principles

The success of CPME is based on the following guiding principles. A commitment to:

- the CPME mission;
- the engagement in continuous quality improvement and learning;
- the contribution of CPME to the profession; and

- the cultivation and support of an environment that reflects a commitment to a broad representation and respect within its member institutions, board and staff, representatives, and all who are served by these groups.

CPME Meetings

Spring 2025

The Council on Podiatric Medical Education held its spring meeting on May 3, 2025. The recommendations emanating from council committees, which completed their deliberations at meetings and conference calls held from February–May, constitute the majority of each CPME agenda and include the review of site visit reports and progress reports from the colleges of podiatric medicine. The Specialty Board Recognition Committee (SBRC) held its meeting in February. The Continuing Education Committee (CEC) and the Residency Review Committee (RRC) held their meetings in March, and the Accreditation Committee, Budget Planning Committee, and Executive Committee met in May.

Fall 2025

The Council on Podiatric Medical Education held its fall meeting on October 17–18, 2025. Most agenda items were based on recommendations from Council committees that met between September and October, including reviews of annual and progress reports from the colleges of podiatric medicine. The Nominating Committee met in July and August; the Continuing Education Committee and Residency Review Committee met in September; and the Accreditation, Budget Planning, and Executive Committees met in October.

CPME Officers and Elections

At the spring meeting, the Council elected its officers to be effective at the close of the Council’s October 2025 meeting: Dr. Alyssa Stephenson was elected chair and Dr. Steven Vyce was elected vice chair.

- Alyssa Stephenson, DPM is a podiatrist at the Carl T. Hayden Veterans Affairs Medical Center in Phoenix, AZ. Dr. Stephenson serves as a college site visit evaluator, residency and fellowship evaluator, and as chair of the Continuing Education Committee and the Specialty Board Recognition Committee.
- Steven Vyce, DPM serves as chief, Department of Podiatric Surgery and Medicine, Yale-New Haven Medical Center in New Haven, CT. Dr. Vyce serves as a CPME residency and fellowship evaluator and as chair of the Residency Review Committee.

Elections to the Council were conducted at the October 2025 meeting. Drs. Harry Schneider and Steven Vyce were elected to a third three-year term as at-large and academic members; Dr. Jonathan Labovitz was elected to a three-year term as an at-large and administrator member; Dr. Laura Sansosti was elected to a three-year term as an at-large and educator/non-administrator member; Dr. Paul Di Liddo was elected to a three-year term as an at-large and

practitioner member; Dr. Jennifer Mathews was elected to a third three-year term as a public member; and Ms. Amanda Soelle was elected to a second three-year term as a public member.

- Harry P. Schneider, DPM is the Residency Program Director at Cambridge Health Alliance in Cambridge, Massachusetts. Dr. Schneider serves as a member of the Residency Review Committee, the Specialty Board Recognition Committee, the Collaborative Residency Evaluation Committee, and as a college and residency site visit evaluator.
- Jonathan Labovitz, DPM is the dean of the Western University of Health Sciences College of Podiatric Medicine in Pomona, California. Dr. Labovitz is a member of the Accreditation Committee and was approved by the Council in July 2025 to serve as chair of the Accreditation Committee. Dr. Labovitz also serves as a college site visit evaluator.
- Laura Sansosti, DPM is the Assistant Dean for Educational Affairs at the Temple University School of Podiatric Medicine in Philadelphia, Pennsylvania. Dr. Sansosti serves as a member of the Accreditation Committee.
- Paul Di Liddo, DPM is the Residency Program Director at Henry Ford Health – Henry Ford Wyandotte Hospital in Saint Clair Shores, Michigan. Dr. Di Liddo serves as a college and residency site visit evaluator and as a member of the Residency Review Committee. He previously served on the Accreditation Committee.
- Jennifer Mathews, PhD is the Vice Provost for Academic Affairs and Institutional Effectiveness and Chief Assessment Officer at the University of Rochester in Rochester, New York. Dr. Mathews currently serves as a member of the Accreditation Committee, as chair of the College Rewrite Ad Hoc Committee, and as a college evaluator.
- Amanda Soelle is the CEO of AJS Consulting in Madison, Wisconsin. Ms. Soelle serves on the Continuing Education Committee and in October 2025 was appointed as chair of this committee.

Accreditation Committee

Jacqueline Prevete, DPM was appointed to the Accreditation Committee in November 2025 to serve as the practitioner representative.

Specialty Board Recognition Committee

Susan Stapleton, PhD was approved by the Council to serve as the chair of the Specialty Board Recognition Committee. Dr. Stapleton is a research professor in the Department of Chemistry at Western Michigan University in Kalamazoo, Michigan. Dr. Stapleton also serves as a member of the Accreditation Committee and as a college evaluator.

Collaborative Residency Evaluation and Education Committee (CREC)

Angela J. McGoff, ICE-CCP, CEO and Executive Director of the American Board of Foot and Ankle Surgery (ABFAS), was appointed as an ABFAS representative on CREC.

Continuing Education Committee

Fall 2025: The Committee reviewed the current continuing education members and terms and welcomed Dr. Barbara Campbell (new FPMB representative), Ms. Samantha Luebbering (new provider representative), and Dr. Robert Joseph (CPME representative) to the Committee. The Committee thanked Dr. Manzi and Dr. Petrov for their service.

Residency Review Committee

In May 2025, the Council reappointed Harry Schneider, DPM and Steven Vyce, DPM as CPME members on the Residency Review Committee. Dr. Vyce was also reappointed as chair of the Committee.

Gary Rothenberg, DPM was appointed as an ABPM representative on the Committee starting August 1, 2025. Dr. Rothenberg is the Adjunct Clinical Associate Professor, Department of Internal Medicine, Division of Metabolism, Endocrinology and Diabetes at The University of Michigan Medical School in Ann Arbor, MI.

Paul Di Liddo, DPM was appointed to serve as a CPME member on the Committee starting November 25, 2025. Dr. Di Liddo is the program director at the Henry Ford Health – Henry Ford Wyandotte Hospital residency program.

The Committee thanked Robert Joseph, DPM and Fred Mechanik, DPM for their service.

GENERAL UPDATES

Virtual Attendance at Meetings

CPME has begun offering virtual options for non-executive sessions of CPME and committee meetings. Registration links will be posted on the CPME website six weeks prior to a meeting for guests and/or observers to register in advance and indicate whether attendance will be in-person or virtually.

Fee Schedule Updates

The CPME approved a change to the fee schedule for colleges and residency and fellowship programs to apply a \$5,000 fee for focused site visits. Institutions will be billed for any additional costs above \$5,000 following the focused site visit.

Terminology Changes

The Council officially updated the terminology used for committee activities, changing “CPME-approved” to “CPME-accredited” for the Residency Review Committee and the Continuing Education Committee, while retaining “CPME-recognized” for the Specialty Board Recognition Committee. This change took effect on July 1, 2025. The Accreditation Committee will continue to use the “CPME-accredited” terminology.

CPME Policy on the Use of Artificial Intelligence

The Council approved a policy on the use of artificial intelligence (AI) by CPME volunteers and institutions, clarifying that institutions are responsible for the accuracy of any information presented to CPME within their reports.

CPME Statement on CAQs

The Council on Podiatric Medical Education (CPME) is responsible for the specialty board and subspecialty certification approval and recognition process on behalf of the podiatric medical profession. The CPME does not recognize, accredit, or approve any Certificates of Added Qualifications (CAQs) within its policies and procedures for specialty board recognition. CAQs are not equivalent to board certification or subspecialty certification, nor can they lead to certification or subspecialty certification in any specific content area. CPME’s position on CAQs remains unchanged and consistent with its longstanding practice. Recent revisions to the CPME 220 Standards and Requirements and the CPME 230 Procedures do not alter this position.

Release of the CPME Conflicts of Interest List

As part of its commitment to transparency and integrity, CPME requires all council members, committee members, evaluators, consultants, and staff to annually disclose any potential conflicts of interest. These disclosures help ensure that decisions related to the accreditation and oversight of programs, institutions, and organizations are made objectively and without bias.

A conflict of interest may arise when an individual has a personal, professional, or financial relationship, current or within the past five years, with an entity under CPME’s jurisdiction. Conflicts include serving in a leadership position within the past five years within the profession as defined as one holding a position on the board of directors, serving as a committee chair, employment, or any other position that calls into question the council member’s ability to fairly perform their duties. In such cases, individuals must recuse themselves from all related discussions, decisions, and voting activities.

Serving as a volunteer within the profession, such as serving on a committee of an organization such as APMA, COTH, ACFAS, ACPM, ABPM, ABFAS, NBPME, as a part of case review, or as an exam writer, would not be considered conflicts.

CPME Publication Updates:

Rewrite of the College Documents: CPME 120, Standards and Requirements for Accrediting Colleges of Podiatric Medicine; CPME 130, Procedures for Accrediting Colleges of Podiatric Medicine; and CPME 109, College Accreditation Eligibility Requirements

Every six years, CPME undertakes a comprehensive review of its standards, requirements, and procedures governing evaluation activities. As part of this process, CPME conducted a 60-day survey of the podiatric community of interest beginning in November 2024 to gather input on key elements of these documents. The survey served to establish baseline information for consideration during the revision process.

An Ad Hoc Advisory Committee, composed of representatives from organizations within the community of interest, was convened to lead the review and revision of CPME 120, CPME 130, and CPME 109. The committee met four times, both virtually and in person, beginning in spring 2025. Upon completion of its work, the committee approved the draft revisions in September 2025, determining that the documents were ready for Council review. At its October 2025 meeting, the Council approved Draft I of CPME 120, CPME 130, and CPME 109 for dissemination and comment.

A survey to obtain feedback on the Draft I documents was disseminated for a 60-day comment period beginning December 1, 2025, until February 1, 2026. Once the comment period closes, CPME will review the feedback received to determine next steps in adopting the revised documents.

CPME Publications 220 and 230: FINAL DOCUMENTS PUBLISHED (Specialty Board Recognition Committee)

In March 2021, the APMA House of Delegates approved a resolution to designate the Joint Committee on the Recognition of Specialty Boards (JCRSB) as a standing committee of the council. In response, CPME adopted amendments to its Bylaws at its October 2021 and April 2022 meetings to align with the APMA action. These changes officially established the JCRSB as a standing committee and restructured its representation.

To reflect this change, CPME renamed the JCRSB to the Specialty Board Recognition Committee (SBRC). As part of the transition, the committee's governing documents—CPME 220 (Criteria and Guidelines for Recognition of a Specialty Board for Podiatric Medical Practice) and CPME 230 (Procedures for Recognition of a Specialty Board for Podiatric Medical Practice)—required revision to reflect the new structure.

An Ad Hoc Advisory Committee began reviewing these documents in fall 2022. Over the course of 18 months, the committee held 13 meetings. In April 2024, the committee submitted Draft I of CPME 220 and 230, along with new supporting documents: CPME 209a and 209b (Eligibility Requirements and Initial Recognition Applications) and CPME 209c (Subspecialty Certification Proposal). CPME approved Draft I of all five documents during a special meeting on May 13, 2024, and opened a 60-day public comment period ending July 15, 2024.

At its October 2024 meeting, the council reviewed initial feedback from the community of interest. Due to the volume of responses, CPME extended its review into the fall and scheduled a follow-up videoconference for December 11, 2024, to determine next steps.

Following a thorough review of the submitted comments, the Council adopted the finalized versions of CPME 220, 230, 209a, 209b, and 209c at its May 3, 2025, meeting. These documents are now in effect.

CPME extends its sincere thanks to the Ad Hoc Advisory Committee members for their dedication, hard work, and invaluable contributions throughout this process. Their efforts have played a critical role in advancing the standards for specialty board certification in podiatric medicine.

CPME PUBLICATIONS 720 AND 730: FINAL DOCUMENTS PUBLISHED (Continuing Education Committee)

CPME adopted the revised CPME 720, Standards and Requirements for Approval of Providers of Continuing Education in Podiatric Medicine, and CPME 730, Procedures for Approval of Providers of Continuing Education in Podiatric Medicine, at its October 2024 meeting. The newly approved documents were disseminated and posted to the CPME website on March 12, 2025, and took effect on July 1, 2025.

The Council extends its sincere appreciation and heartfelt gratitude to the CE Ad Hoc Advisory Committee members for their hard work, dedication, and outstanding contributions throughout this lengthy process. Their commitment to excellence and the advancement of continuing education in podiatric medicine has been invaluable.

Colleges of Podiatric Medicine

The Accreditation Committee is responsible for recommending to the Council candidacy of new and accreditation of existing colleges leading to the professional degree in podiatric medicine (DPM). The Committee reviews evaluation reports, annual reports, progress reports, and other information submitted by the colleges at its biannual meetings to ensure compliance with the standards and requirements found within CPME 120, *Standards and Requirements for Accrediting Colleges of Podiatric Medicine*.

The Council took the following [accreditation actions at its 2025 meetings](#):

January 2025

- **University of Texas Rio Grande Valley School of Podiatric Medicine** – At its January 2025 meeting, the Council elected, based on a focused on-site evaluation, to grant preaccreditation status to the University of Texas Rio Grande Valley School of Podiatric Medicine as there are no identified concerns or areas of noncompliance with accreditation standards and requirements.

May 2025

- **Kent State University College of Podiatric Medicine** – At its May 2025 meeting, CPME elected, based on an on-site evaluation, to extend accreditation through April 2033.
- **LECOM School of Podiatric Medicine** – At its May 2025 meeting, CPME elected, based on an on-site evaluation, to grant preaccreditation status to the LECOM School of Podiatric Medicine as there are no identified concerns or areas of noncompliance with accreditation standards or requirements.
- **New York College of Podiatric Medicine of Touro University** – At its May 2025 meeting, CPME elected, based on a focused evaluation visit, to affirm that the substantive change in ownership procedures has been completed for the New York College of Podiatric Medicine of Touro University. NYCPM of Touro University is scheduled for a required site visit by the Middle States Commission on Higher Education in June 2025 before the acquisition is finalized.
- **Temple University School of Podiatric Medicine** – At its May 2025 meeting, CPME voted to extend accreditation through April 2031 as the school is in compliance with all accreditation standards and demonstrated full compliance within one year of the comprehensive evaluation decision.

October 2025

- **Barry University School of Podiatric Medicine** – At its October 2025 meeting, CPME voted to extend accreditation through October 2032 and to change the accreditation status to accreditation, from accreditation with monitoring status, as the school is in

compliance with all accreditation standards and demonstrated full compliance within one year of the comprehensive evaluation decision.

- **Samuel Merritt University College of Podiatric Medicine** – At its October 2025 meeting, CPME voted to change the college’s accreditation status to accreditation with monitoring as the college has been cited with an area of noncompliance related to Standard 2E, Reporting to CPME. In addition, CPME approved the college’s substantive change requests related to a change in the way student progress is measured as the university has moved to trimesters and the substantive change related to the move to a new campus location with no further information required. The move is anticipated in January 2026, and the next comprehensive site visit is scheduled for spring/summer 2027. The required focused site visit to assess the new college location will be scheduled in 2026.
- **University of Texas Rio Grande Valley School of Podiatric Medicine** – At its October 2025 meeting, CPME voted to extend preaccreditation for one additional year as there are substantial noncompliance issues that the Accreditation Committee and Council determined could be resolved within a relatively limited period of time. The Council determined that two accreditation standards are in noncompliance (Standards 3B Chief Academic Officer and 4F Curricular Evaluation). Based on this decision, the Council determined that a focused on-site visit is required to assess compliance before accreditation may be granted and this visit will take place November 10, 2025, with an accreditation decision in late 2025.

November 2025

- **University of Texas Rio Grande Valley School of Podiatric Medicine** – At its November 25, 2025, meeting, CPME voted to grant accreditation to the UTRGV SOPM through October 2029 as there are no identified areas of noncompliance with accreditation standards and requirements.

College On-Site Visits 2025

- The focused site visit to assess preaccreditation of the University of Texas Rio Grande Valley School of Podiatric Medicine in Harlingen, Texas took place on January 6, 2025.
- The focused site visit to assess the substantive change in ownership of the New York College of Podiatric Medicine of Touro University in New York, New York took place March 31, 2025.
- The comprehensive on-site evaluation to assess accreditation of the University of Texas Rio Grande Valley School of Podiatric Medicine in Harlingen, Texas took place May 19-22, 2025.
- The focused site visit to assess accreditation of the University of Texas Rio Grande Valley School of Podiatric Medicine in Harlingen, Texas took place on November 10, 2025.

Residency Programs

The Residency Review Committee (RRC) is a collaborative effort of CPME-recognized specialty boards, the Council of Teaching Hospitals of the American Association of Colleges of Podiatric Medicine (COTH), and CPME. The Committee reviews, takes actions on, and makes recommendations concerning podiatric residency and fellowship programs in accordance with procedures and requirements set forth by the Council in CPME 320, *Standards and Requirements for Approval of Podiatric Medicine and Surgery Residencies*. The RRC meets semi-annually to deliberate and recommend approval of residency and fellowship programs.

Fellowship actions taken during 2025 RRC and CPME meetings, and through e-ballots and conference calls can be found at cpme.org/residencies/approval-actions.

During 2025, the Council and RRC conducted virtual and on-site evaluations of 36 new and approved residency programs and 5 new and approved fellowship programs. As of December 2025, the Council had authorized 614 first-year residency positions and 33 first-year fellowship positions at 19 CPME approved fellowships.

The RRC conducted its first Program Director and Coordinator Training Workshop in May 2025. Sixty people, including 23 program directors and 37 coordinators attended this full-day training workshop.

Continuing Education Providers

The CEC is responsible for reviewing applications for accreditation of new providers, petitions for continuing accreditation, evaluation reports, progress reports, and other information submitted by the providers within its review area. The Council accredits providers of continuing education that demonstrate and maintain compliance with the standards and requirements identified in CPME 720, *Standards and Requirements for Approval of Continuing Education Providers in Podiatric Medicine*. The CEC meets semi-annually to deliberate and recommend approval of continuing education providers.

As of December 2025, the Council accredits 56 providers of continuing education in podiatric medicine.

Specialty Boards

As delegated by the Council, the Specialty Board Recognition Committee (SBRC) is responsible for recommending to the Council the granting of new and continuing recognition to specialty boards in podiatric medicine. The SBRC reviews applications, annual reports, petitions for continued recognition, progress reports, and other information submitted by the specialty

boards within its review area at their annual meeting to ensure compliance with the standards and requirements found within CPME 220, *Standards and Requirements for Recognition of a Specialty Board for Podiatric Medical Practice*.

Certification processes are identified for podiatric surgery and podiatric medicine and orthopedics. The Council recognizes the American Board of Foot and Ankle Surgery (ABFAS) and the American Board of Podiatric Medicine (ABPM).

During its February 8, 2025, meeting the SBRC conducted a review of the annual reports submitted by ABFAS and ABPM.

Collaborative Residency Evaluator and Education Committee

CREC held an Evaluator Training Workshop for new and existing evaluators on May 10, 2025.

The Committee met on December 6, 2025, in Nashville, TN, for its annual winter meeting. The Committee conducted an audit of evaluators and drafted a self-study.

Department of Education

The Council holds recognition as the accrediting body for first professional degree programs in podiatric medicine from the Secretary of the US Department of Education (USDE), appearing on the list of nationally recognized accrediting agencies that the US Secretary of Education identifies as reliable authorities concerning the quality of education offered by educational institutions or programs. The Council has appeared on the Secretary's list since the recognition process was first legislated in 1952.

In spring 2022, CPME received official notice from the Secretary of Education that CPME's recognition by the USDE was renewed for five years without any deficiencies until 2027. The next petition for continued recognition was submitted in January 2025 with focused reviews by the USDE throughout 2026 prior to the 2027 hearing.

Council on Higher Education Accreditation

CPME holds recognition from the Council on Higher Education Accreditation (CHEA) as the specialized/professional accrediting agency for colleges of podiatric medicine, first professional degree of Doctor of Podiatric Medicine, and the pre-accreditation category of candidate status for developing colleges, schools, and programs of podiatric medicine.

On July 28, 2025, Drs. Marcoux, Violand, and Stagliano appeared before CHEA's Committee on Recognition to defend CPME's petition for continued recognition. The Committee on Recognition submitted their recognition decision to the CHEA Board of Directors who met on September 29, 2025. Following the Board's meeting, CPME was notified that the CHEA BOD accepted the Committee on Recognition's recommendation and granted recognition to APMA-CPME for the fullest term of seven (7) years with no issues or follow up.

Association of Specialized and Professional Accreditors

The Council is a charter member of the Association of Specialized and Professional Accreditors (ASPA), which was established in 1993 as an umbrella organization to represent the interests of specialized accreditation. ASPA’s mission is to communicate the value of specialized and professional higher education accreditation and promote quality by facilitating discussion among and providing educational opportunities for programmatic accreditors.
